Safeguarding children with disabilities in residential settings

The Government response to the review into safeguarding children with disabilities and complex health needs in residential settings by the Child Safeguarding Practice Review Panel, was published at the end of last year.

There were two specific recommendations that the Panel directed to providers of residential education and care for disabled children with complex health needs.

These were:

 to ensure that practitioners understand the requirements for legally compliant practice in relation to Deprivation of Liberty (DoL) Safeguards, local authorities, health services and residential settings should review their current systems, procedures, and practice to determine their readiness for meeting the requirements under this framework when it is implemented.

 that national leadership and investment by providers is urgently required to address the longstanding challenges in recruiting, retaining and developing a skilled workforce in residential settings.

There are no significant changes to day-to-day referral practice, but there have been developments in how statutory partners should function, in particular the removal of the independent chair role.

The Annual Report of His Majesty's Chief Inspector of Education, Children's Services and Skills 2022/23

At the end of November, Ofsted published its annual report and concludes that there are reasons for optimism despite the lingering effects of the pandemic and the many challenges that remain. There is much criticism of the approach taken in England to inspection and it is noteworthy that the new Chief Inspector Sir Martyn Oliver in his opening statement seeks to emphasise a changed approach.

Over the coming months Ofsted will be launching 'The Big Listen' to look to improve the regulator's approach. Ofsted report their view that the children's homes continue to improve and comment on the introduction of new regulation for the supported accommodation sector. However, as last year they highlight the biggest challenge facing the residential care is recruitment.

The report highlights the need to provide children with a

space that encourages their growth and development, where they can enjoy their childhood, and build resilience and confidence. It also says, "The people working in education and care deserve recognition and support, not a narrative of decline. It's not a fair reflection of their work and it's not fair on the children whose lives they help to shape."

Children's Commissioner - extension to the Big Ambition survey

Over the last few months, the Children's Commissioner has been travelling all over England talking to children and young people to hear what they want from politicians ahead of the next general election. So far 300,000 have responded to **The Big Ambition** survey but they want to give more people the chance to take part so this has been extended, with a new deadline of 19th January 2024.

Responsible and Nominated Individual Training

This course is designed to meet the needs of aspiring, new and experienced Responsible & Nomintated Individuals for children's homes and supported accommodation. The course is a series of very practical, live online sessions addressing the day to day life of the NI/RI with lots of reflection and embedding practice between the sessions.

The Leadership & Management standard is very similar across both sectors, so we are running joint RI/NI programmes, but also trialling a course solely for NIs in supported accommodation.

This two-day course, delivered via zoom in six 2-hour sessions, costs £264+vat, reduced to £132+vat for members.

Why Language Matters!

We know that taking risks is an important part of growing up and learning independence. However, in a blog for its 'Why Language Matters' series, NSPCC Learning argues that using the term "risky behaviour" when focusing on teenagers experiencing abuse and exploitation can play down safeguarding concerns.

The blog explains that using this term can incorrectly imply the child is responsible for the harm they are experiencing and can divert a response to address the child's behaviour rather than providing protection from their abuser.

Training for Supported Accommodation Providers

Developing specialisms communities of interest As the communities continue to grow, we wanted to remind current members that these meetings are contain essential information to support your statements of purpose, improve the care of the young people you support AND lighten to the load of the Registered Manager. If you miss a meeting you can also retrieve the resources from the archive in the members' areas, but the best way to get the most out of your memberships is to ensure the dates are saved in your diaries and you attend on the day.

Leading residential care can be an isolating experience and in truth is a job best shared. We've been working with leaders across the sector to create communities that regularly meet in line to discuss the issues that matter to you young people. By identifying leads for key areas, such as online safety, managers share the load with senior team members, then by connecting your team with similar leads in other homes we become less insular in practice and all learn how to improve.

The communities meet quarterly with 2-3 hours of CPD including updates on recent research, speakers, a surgery and sharing of great practice.

As always we've found ways to keep the costs very low and the more you engage the less you pay - joining one community is £99+vat for a whole year, additional groups at £79+vat each or we now have a **'whole home offer' paying just £399+vat annually, to have a staff member (can be different members for each community) from your home at each of the NOW SEVEN communities.**
